



FIGURE 8 RACES WAIVER

IN CONSIDERATION of being permitted to be a driver of Pit Crew for the Figure 8 Races, the undersigned, for himself, and personal representatives, heirs, and next of kin:

1. HEREBY RELEASES, WAIVES LIABILITY, DISCHARGES AND COVENANTS NOT TO SUE Teton County, Teton County Fair, Teton County Fair Board, Town of Jackson, their officers and members, officials, car owners, drivers, participants, persons in the restricted area, promoters, sponsors, advertisers of the Figure 8 Races (the "RELEASEES"). Further, I release said RELEASEES from all liability to me for all loss of damage, and any claim or demands therefore, on account of injury to the persons of property or my death, whether caused by the negligence of Releasees or otherwise while I am on Town land or the Fairgrounds participating in the Figure 8 Races as driver or pit crew, and
2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the RELEASEES and each of them from any loss, liability, damage or cost they may incur due to my presence and participation in the Figure 8 Races whether caused by the negligence of the RELEASEES or otherwise, and
3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK of bodily injury, death and property damage due to negligence of RELEASEES or otherwise while participating in the Figure 8 Races, and
4. I expressly agree that the foregoing Release Waiver of Liability and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the law of the State of Wyoming and that if any portion is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
5. I hereby irrevocably give my permission for the Teton County Fair Board and Fairgrounds to copyright and/or publish, reproduce or otherwise use my name, voice and likeness and/or written material, photographs, motion pictures, and audio-visual, magnetic recordings about or by me for instruction, art, advertising, trade or any other lawful purpose.
6. I HAVE READ AND VOLUNTARILY SIGN THIS RELEASE AND WAIVER OF ALL LIABILITY AND INDEMNITY AGREEMENT, and further agree that no real representation, statements of inducement apart from the foregoing written agreement have been made.
